Our purpose in asking you to sign this form is to document that we have informed you that this office may use and disclose all your health information in our possession (collectively "Protected Health Information").

- · Obtain payment from third-party payers.
- Conduct normal healthcare operations such as quality assessments and physician certifications.

<ul> <li>A. The insurance company has an obligation to the patient, <u>not</u> to the doctor.</li> <li>The patient alone is obligated to the doctor for payment of services.</li> <li>C. The doctor <u>cannot</u> state what services an insurance company covers or the amount of coverage. The patient must determine coverage from their insurance company, benefits administrator or agent. Call your insurance company if you have any questions about your coverage. The patient alone is responsible for determining coverage.</li> <li>D. Most insurance companies send payment from 14 days up to 60 days after the visit. This office will extend credit to patients for up to 90 days from the date services are rendered while waiting for the insurance company to pay. **IMPORTANT**: If the insurance company does not pay the bill within 90 days, the amount due automatically becomes the responsibility of the patient. The patient may seek reimbursement directly from the insurance company after 90 days, if he or she so desires.</li> <li>As stated above, our office will submit the original bill to your insurance company. This in no way relieves the patient of their obligation to the doctor nor does it imply that the fees for services are thereby settled. Payment of the balance is required at the time of service unless prior individual arrangements are made. Your cooperation in this matter will benefit all concerned.</li> <li>For patients with Master Medical (a product of Blue Cross Blue Shield) payment is required in full. You will be required to pay consultation, allergy testing, allergy immunotherapy and allergy serum fees up front at the time of service. We bill electronically and usually it only takes one to two (1-2) weeks to receive your payment from your insurance company. Should further questions arise, please call the office.</li> <li>For patients with managed care, HMO, POS or any other insurance that requires a referral, the patient is responsible for making sure that he or she has a VALID REFERRAL before the date of the visit. Since allergy serum is made individually for a specific patient, it cannot be used for any other patient.
